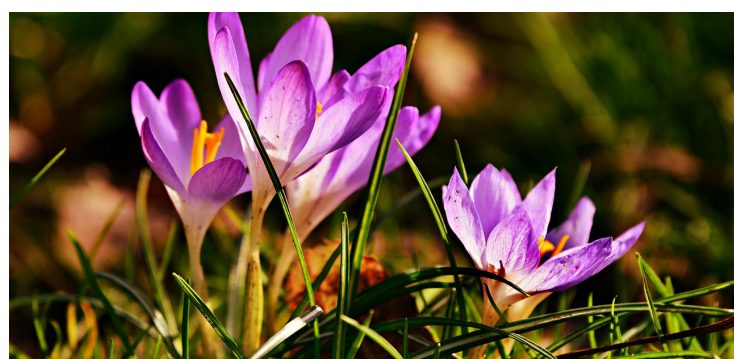

LADOGA 2024 WDW GRANT - RD 1

On or about June 28, 2024, the Town of Ladoga intends to apply to the Indiana Office of Community and Rural Affairs for a grant from the State Community Development Block Grant (CDBG) Wastewater Drinking Water Program. This program is funded by Title I of the Federal Housing and Community Development Act of 1974, as amended. These funds are to be used for a community development project that will include the following activities: rehabilitation of the drinking water system. The total amount of CDBG funds to be requested is \$600,000. The amount of CDBG funds proposed to be used for activities that will benefit low- and moderate-income persons is \$311,520. The Applicant also proposes to expend an estimated \$202,000 in non-CDBG funds on the project. These non-CDBG funds will be derived from the following sources: ARPA Funds and Water savings.

The Town of Ladoga will hold a public hearing on April 13, 2024 at 9:00 AM in Ladoga Town Hall at 121 E. Main St. Ladoga IN 47954 to provide interested parties an opportunity to express their views on the proposed federally funded CDBG project. ABSTRACT – ORDINANCE 9-2024 – An Ordinance Amending City Parking Ordinance to Establish 72-Hour Limit at City Parking Lot in the 400 Block of East Main Street in Crawfordsville, Indiana

Under City Code Section 72.26, Schedule IX of Chapter 77 of the Crawfordsville Code of Ordinances is amended to add the following parking designation:

The Street Commissioner is hereby authorized and directed to install the necessary signage or painting, or both, to effectuate this ordinance, with such markings as Indiana law requires.

This ordinance will be in full force and effect immediately upon passage and after any necessary publication. All ordinances or part of ordinances that conflict with this ordinance are hereby repealed.

Violations of the ordinance are punishable by civil fines and penalties under the City's traffic ordinances, Title VII of the Crawfordsville City Code.
