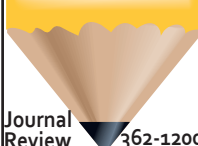

Notice is hereby given that the Montgomery County Commissioners will receive sealed proposals and bids until the hour of 8:00 a.m. on Monday, May 13, 2024 at the Commissioner's Office, 1580 Constitution Row – Suite E, Crawfordsville, Indiana 47933 for the following:

The lease of certain real estate owned by the Board of County Commissioners of Montgomery County, consisting of approximately 4.77 acres. The acreage is currently planted in orchard/timothy/alfalfa mix from Cisco. The real estate is located on southwest corner of US Highway 136 East and Nucor Road in Montgomery County, Indiana.

Proposals will be evaluated based primarily on price but will also be evaluated on the proposed use of the real estate and terms and conditions of the lease.
